ORDER:

The Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No. 5 of 2016) has come into force w.e.f 08.02.2016 by virtue of notification issued in G.O. 2nd read above.

2. In the reference 3rd read above, the Director of Town & Country Planning has requested the Government for constitution of Palnadu Urban Development Authority (PAUDA), with a jurisdiction of 8 ULBs, 349 Villages in 28 Mandals to an extent of **7281.31** Sq.Kms and population of 21,36,660 as per 2011 census with head quarters at Narasaraopeta under section 3 & 4 of Chapter-II of APMR&UDA Act, 2016 duly deleting certain area from the existing APCRDA and ONUDA jurisdiction.

3. Government after careful examination of the matter have decided to declare the area of 7281.31 Sq. Kms covering 8 ULBs, 349 Villages in 28 Mandals to an extent of **7281.31** Sq.Kms with head quarters at Narasaraopeta under section 3 & 4 of Chapter-II of APMR&UDA Act, 2016 duly deleting certain area from the existing APCRDA and ONUDA jurisdiction, as given in Notification – I and constitute Palnadu Urban Development Authority (PAUDA) with Head Quarter at Narasaraopeta as given in Notification – II.

4. The Urban Development Authority shall function from the office in Narasaraopeta Town with the support of its staff. The expenditure towards establishment and other secretarial assistance shall be completely borne by Palnadu Urban Development Authority (PAUDA). The Urban Development Authority shall function with their own revenue.

5. The modalities for Development of lands, Preparation of Master Plan and Zonal Development plans, Acquisition and disposal of lands, Inspection and penalties etc., shall be followed as per the provisions of the Andhra

Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No.5 of 2016).

6. The appended notification will be published in an Extraordinary issue of the Andhra Pradesh Gazette, dated:26.12.2022.

7. The Commissioner of Printing, Stationery and Stores Purchase, Andhra Pradesh, Vijayawada is requested to supply 10 copies of the Extraordinary issue of the Andhra Pradesh Gazette.

NOTIFICATION-I

In exercise of the powers conferred by sub-section (1) of section 3 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016 (Act No.5 of 2016), the Government of Andhra Pradesh having regard to the need for the promotion of development activities relating to as a Urban Development Authority to achieve the

objectives of the region witnesses tremendous growth in the domains of Industries, Imports and Exports etc. hereby specify a special Urban Development Area for the area comprised within the jurisdiction of Palnadu District covering 8 ULBs, 349 Villages in 28 Mandals with head quarters at Narasaraopeta with an extent of **7281.31** Sq.Kms and a population of 21,36,660 duly deleting certain area from the existing APCRDA and ONUDA jurisdiction and Villages as specified in the Schedule appended to this notification to be a Urban Development Area for the purpose of the said Act and the said Area shall be as "Palnadu Urban Development Area (PAUDA)".

NOTIFICATION - II

In exercise of the powers conferred by sub-section (1) and clause (ii) of subsection (3) of section 4 of the Andhra Pradesh Metropolitan Region and Urban Development Authorities Act, 2016, the Government of Andhra Pradesh hereby constitute an Urban Development Authority for the area specified in the Notification - I above for the purpose of the said Act and the said Authority shall be called as the "Palnadu Urban Development Authority (PAUDA)" and shall consist of the following members, namely:-

a)	The Chairperson to be appointed by the Government;	
b)	the 'Vice-Chairperson' - who is a Government Officer to be appointed by the Government, shall be the whole time Chief Executive Officer of the Authority and shall be the	Member Convener
c)	OSD /Joint / Deputy Secretary to Government, Municipal Administration & Urban Development Department	Member;
d)	Joint / Deputy Secretary to Government, Finance Department - Member;	Member;
e)	Officers not more than four, dealing with Transportation, Roads & Buildings, Energy, 12 Environment or such other departments as may be deemed necessary by the Government	Members;
f)	District Collector of the development area	Member;
g)	Director of Town & Country Planning or his nominee	Member;
And		
h)	Three experts of national or international repute who possess knowledge in urban governance, urban planning, conservation, environment and transportation to be appointed by the Government	Members;

(2) Any other officer or expert whom the Government thinks necessary may be invited to the meetings of the authority as special invitee.
